

# 1 INDEMNIFICATION AGREEMENT

In consideration for \_\_\_\_\_ (print minor's name) ("minor") being permitted by Wave Trek Rescue LLC ("WAVE TREK") to participate in its whitewater rafting and kayaking activities, I agree to this **WAIVER, RELEASE AND INDEMNIFICATION**:

The undersigned parent(s) and/or guardian(s) of the minor, for themselves and on behalf of the minor, join in the foregoing **PARTICIPANT AGREEMENT, RELEASE AND ACKNOWLEDGMENT OF RISK** (copy attached hereto) and stipulate and agree to **SAVE AND HOLD HARMLESS, INDEMNIFY AND FOREVER DEFEND WAVE TREK**, its shareholders, officers, directors, agents, employees, volunteers, and all other persons or entities acting in any capacity on its behalf, from and against any claims, actions and demands (**including those based on alleged negligence**) made or brought by the minor or by anyone on behalf of the minor, as a result of the minor's participation in activities with **WAVE TREK**, as well as all expenses and liabilities (including reasonable attorneys' fees and costs) incurred by **WAVE TREK** resulting from any such claims, actions or demands.

**I HEREBY REPRESENT THAT THE MINOR IS IN GOOD HEALTH, THAT THERE ARE NO SPECIAL PROBLEMS ASSOCIATED WITH THE CARE OF THE MINOR, AND THAT I HAVE ADEQUATELY INFORMED WAVE TREK'S PERSONNEL OF ANY SPECIAL INSTRUCTIONS REGARDING THE MINOR.**

I authorize **WAVE TREK** personnel to render emergency first aid to the minor, and to call for medical care for the minor or to transport the minor to a medical facility or hospital (if available) if, in the opinion of such personnel, medical attention is needed for the minor. I further authorize appropriate medical personnel to render such medical treatment as is necessary for the health of the minor, in their professional opinion. I agree that once the minor is transported to the medical facility or hospital, **WAVE TREK** shall have no further responsibility for the minor, and I agree to pay all costs associated with such medical care and transportation.

**I have fully informed myself of the contents of this Indemnification Agreement by reading it in its entirety before I signed it. I have read and understood this document, and I agree to be bound by its terms. I understand that this agreement may limit my right to maintain a lawsuit against WAVE TREK in the event of injury, death or property damage to the minor, and may subject me to financial liability in the event the minor, or someone on behalf of the minor, makes a claim against WAVE TREK for injuries or damages suffered by the minor.**
